Healthy Aging Imperative

- 85+ population will grow by 74%
- 36% people over 65 report having a disability*
- 51.5% of Older Adults over 75 have disabilities (28M people are 70 or older)
- 23% of older adults over 65 report being obese*
- 32.5% of older adults over 65 have no leisure time physical activity*
- 80% of people older than 60 are living with one chronic illness, but 50% older than 60 are living with two chronic illnesses (CDC, 2003)
- Chronic disease accounts for 75% of healthcare costs

Trends in Driving = Need for more Transportation Choices

- 31M older licensed drivers in 2007 (19% increase since 1997)
- Nearly 1 M persons age 70+ stop driving each year
- Gap between Driving Expectancy
- & Life Expectancy
 - Men 6/7yrs.
 - Women 10yrs.





Smart Growth Can Reduce Community Chronic Disease

- It promotes safe walking & reduce pedestrian fatalaties
- Provides healthier environment to live in
- Provides access to health and preventive care
- Helps people age at home
- It improves social connections potentially reducing depression and substance abuse
- Access to transportation options ensures transitioning from hospital to home for rehabilitation
- Caregiver transportation options help caregivers











Economic Benefits of Smart Growth for Seniors

- Reduces business costs: Metlife study 7M working caregivers employers lose \$ 36.3B annually due to lost productivity
- Helps families retain assets: cost of family based long-term care \$ 375B vs. \$ 97B Medicaid (Medstat Medicaid Figures)
- Reduces LTC costs: Community based long-term care vs. institutional care (\$ 26K vs. \$ 9K per year person, AARP)
- Reduces transit cost: fixed route trips vs. paratransit trips (\$ 5/ride vs. \$ 30-65/ride*) 10B trips taken a year (APTA)

- Requires dual community analysis
 - Accessibility needs of people
 - Assessment of in the community
- Identifies and fills gaps in livability/accessibility
- Start Mobility Coaching & Counseling Programs



Are you 60 years of age or older and a driver? Are you comfortable in all traffic situations as you were 10 or 20 years ago? How comfortable in traffic do you expect to be in the next 10 or 20 years?

If you are completely comfortable in all driving situations, that is good news. However, you might know older drives who are too hestant, slow or just unable to continue driving. It can happen and, no doubt, you want to be sure this does not happen to you.

It is critically important that older drivers are as safe as they can possibly be because they will be driving on the nation's roads in increasing numbers. As the number of older adults in the United States increases dramatically in the coming decades, so too will the number of older drivers on the roads. In fact, the 29 million older drivers now will almost double, reaching 57 million in about 20 years.

Certain changes related to the aging process may make the highly complex skill of driving a car increasingly difficult. These include changes in vision, hearing, flexibility and strength. However, these changes are not consistent from one individual to anothe, and they do not happen at the same agin each person.


